In accordance with Act CI of 2018 on the census, a Population and Housing Census is to be conducted in Hungary, which will reflect the situation of households on **1 October 2022**. The census is the largest data collection in Hungary, with a huge impact on the lives of all of us. Census data are essential for making important decisions affecting the country and its settlements.

- **including foreign nationals who reside in Hungary for at least three months.**

Please fill in the **HOUSING QUESTIONNAIRE** first, then continue with completing the **PERSONAL QUESTIONNAIRES, as many as the number of persons living at this address**. The questionnaires should be completed by any adult person, who lives there. Information on children should be provided by the parents.

Once you answered the questions, you will receive a message of confirmation. **Please keep the confirmation code, save it or take a photo of it** so that you can use it later to confirm that you have already complied with your obligation of completing the census.

After you completed the questionnaire, **enter the online prize draw!** 5 vouchers of HUF 100 000 each will be drawn every day.

Addresses where the online questionnaire has not been completed during the self-completion period will be visited by census enumerators **between 17 October and 20 November 2022**.

If you have missed the census, you have to visit your Mayor's Office, where you may submit your data **between 21 and 28 November 2022**.
